

## INVESTMENT STRATEGY

Pacific Precious is a focused Precious Metals Multi Strategy fund within the sector Liquid Alternatives with a Targeted Absolute Return approach and the yearly return target is OMRXTBILL +10% over a full economic cycle.

The funds main strategies are L/S Precious Metals, Allocation PM-Streaming/Business-companies, L/S Precious Metals Mining Companies. The normal allocation is 50%, 25%, 25% but the manager uses an unconstrained tactical allocation between them and underlying sub-strategies (L/S PM: Gold, Silver+PP) (L/S PM Mining Companies - no net long position taken actively).

The fund mitigates issuer risks to a bare minimum and uses a Dynamic FX Hedge (USD/SEK) to either protect or to enhance returns. Volatility is aimed to be 12 with a soft interval 8-16 and hard interval 4-20. The risk classification shall thereby be able to vary between 4, 5 and 6 but normally be 5.

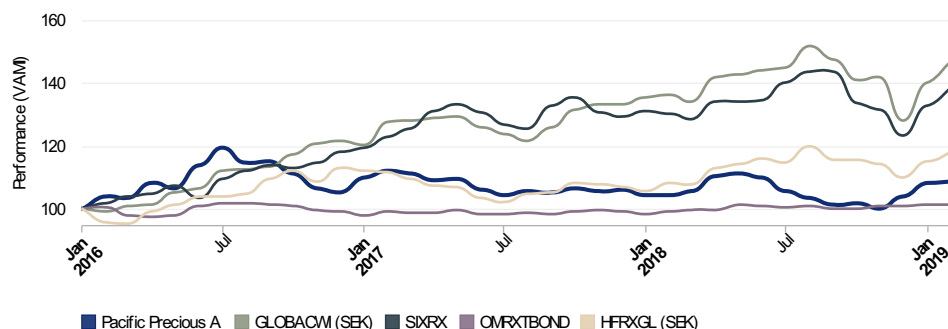
The fund has a concentrated portfolio in very liquid holdings (~30-40) and in markets with large capacity which enables strategies and return potential to be independent of the funds future size as well as inconstant market environments. Being a Swedish UCITS fund all aspects of security, costs and transparency are optimized.

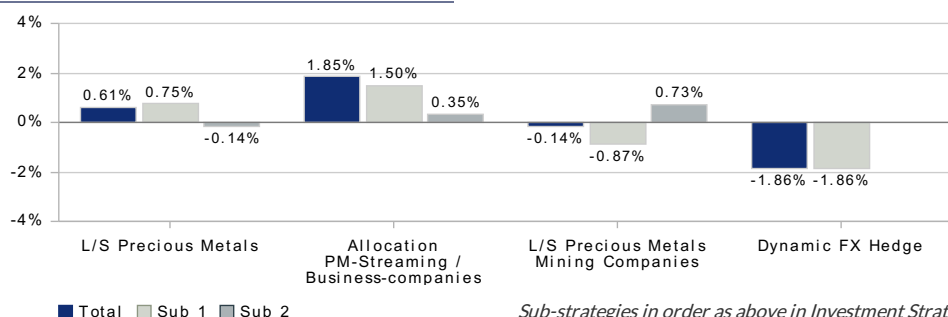
